Acknowledgment of entries will be made as soon as practicable with entry identification cards. The person accompanying the dog to the show must show this identification before the dog will be received. No entry shall be made and no entry shall be accepted which specifies conditions as to its acceptance.

Entry fees shall not be refunded in the event the dog is absent, excused, disqualified by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to complete the show, no refund of entry will be made. **No refund of duplicate entries.**

The Duluth Kennel Club, Inc., does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events.

Management is NOT responsible for the loss of, damage to, or death of any dog exhibited, or for the possessions of any participant, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.

Consult judging program for time of judging.

Judges will not wait for any dog holding up a class. Owners/agents are responsible for having their dogs in the judging rings when classes are called. The Show-giving Club and the Secretary have no obligation or responsibility for providing services through a public address system or stewards or runners for the purpose of calling/locating dogs. **Dogs may arrive** any time prior to their scheduled time of judging. Dogs not needed for further judging will be excused.

Crating Space will be available on a limited basis. The trial site requires a tarp to be placed on the floor beneath your crates. Crates may be left overnight; however, Arrowhead Dog Training, LLC will not be responsible for any lost or damaged items left at the show site.

All dogs present must be on leash or confined to their crates unless they are being judged.

Bitches in season (on the date of the show) are not permitted to compete. . . . American Kennel Club *Obedience Regulation*, amended to January 1, 2005. |

REFUND OF ENTRY FEES minus **\$10.00** per event, will be given to the entrants of bitches in these obedience and rally trials, upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial, if received one half hour before start of all judging on the trial date.

Rules and regulations of civil authorities and/or building or location restrictions will apply to all persons on the trial premises. This is a **SMOKE-FREE BUILDING**.

Outside exercise area is provided . . . please use grassy exercise area on the road side of the building. **All other areas are off-limits including the pond beyond the wooden fencing.** Failure to pick up after your dog may result in being asked to leave the trial with no refund of entry fees, pick-up bags and depositories are readily available for your convenience.

Parking: All parking is free next to the building. No overnight RV parking will be allowed on the trial site.

DIRECTIONS TO THE TRIAL SITE

From the north

From Hwy 53, take a left (north) onto Midway Rd (Cty Hwy 13). Travel ½ mile to the stop sign at Martin Rd (Cty Hwy 9). Take a right onto Martin Rd (east) and travel approximately 10 miles to Jean Duluth Road (Cty Hwy 37) at a “T” in the road. Turn left onto Jean Duluth Road (north) and travel 1 mile to the crossroad of West Tischer Road (Billy’s Bar & Grill is on the corner). Turn right (east) onto West Tischer and travel 2 miles to a 90 degree turn of the road to the left (the road has now become North Tischer). Continue on North Tischer for approximately ¼ mile. The facility is on your left.

From the northeast

From Hwy 61 (Scenic) & Expressway, take a right turn onto Superior St and travel ½ mile. Turn right (north) onto Lester River Road and travel approximately 3 miles to a stop sign at Strand Road. Turn left (west) onto Strand Road and travel 1 mile to a stop sign at North Tischer Road. Turn left (south) onto North Tischer Road and travel ¼ mile. The facility is on your right.

From the south and west

From I-35, take the Hwy 61 exit (North Shore) and travel approximately 3 miles to 60th Ave East. Turn left (north) and travel one block to Superior St. Turn right onto Superior Street and travel two block to Lester River Road (over the river bridge). Turn left onto Lester River Road and travel approximately 3 miles to a stop sign at Strand Road. Turn left (west) onto Strand Road and travel 1 mile to a stop sign at North Tischer Road. ## INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
  2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
  3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
  4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. ## INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
